Tracking

The security of your goods is essential to us and therefore we ensure that your goods are handled safely and secure at all times. All goods transported by us are tracked via our online tracking and tracing system leaving you our valued client with peace of mind at all times.

Customs Clearing

Our focus in this area is to provide for a convenient, reliable and efficient multimodal Clearing and Forwarding of Import and Export for cargo to our clients in South Africa and in the rest of the world. We also render Import and Export Services on Air freight, Sea freight & Road freight. We want to be amongst the top customs and clearing agencies in Africa and to efficiently manage a multiple number of service points with a greater emphasis placed on services delivered through the port of Durban.

Import & Export Customs Clearing

We are fully accredited Clearing Agent in accordance with Section 64E of the Customs and Excise Act No91 of 1964, this is also referred to as a SARS preferred trader. All goods entering into or departing from South Africa require customs clearing. We are able to provide a swift customs clearing service at competitive rates. With our online system we are linked via EDI (Electronic Data Interchange) to Customs. Our focus in this area is to provide for a convenient, reliable and efficient multimodal Clearing and Forwarding of Import and Export for cargo to our clients in South Africa and in the rest of the world.

Inbound Process

Upon receipt of shipment details and/or documentation, we telephonically and electronically track cargo in order to establish estimated time of arrival and current shipment status. Once established, these details are verified with the relative Port and Carrier authorities in order to ensure the accuracy of details.

Upon receipt of required customs clearance documentation, customs clearance is processed and delivery to client is arranged accordingly. Simultaneously, the client is forwarded regular shipment updates, until they have confirmed receipt of cargo to their satisfaction and outstanding equipment is returned to the respective parties.

Thereafter, the shipment is immediately invoiced. A copy of the invoice, accompanied by a copy of the customs clearance documents, is mailed to the client. The original invoice and original customs clearance documentation is then couriered as arranged with the client.

Warehousing

Through our associate we have warehousing solutions that will provide value for your business whether on a dedicated basis or shared basis.

We offer the following warehousing combinations close to OR Tambo International Airport and Durban Port for Bonded and Free Store Bond:

We provide supply chain, warehousing and logistics management solutions. If your company has a need for warehouse space, distribution services or increased seasonal storage we have the solution for you.
